## Deposit, Fees and Tax

- A Non Refundable Deposit \$300.00 is required to confirm your date and time.
- 50% Deposit for you final order, must be paid seven business days prior to the event.
  - Sale Tax 6.65%
  - If you need Pareve, 20% will be added to all Non-Bakery Goods.
    - Double Wrapped & Sealed Add 15%
  - Small group fee \$50.00 for all events under 30 guest.

## Payment

We accept Cash, Check, Visa, Master Card, American Express and ITEX.

Cash and Check payment receive 1% discount.

ITEX trade on bakery and catering foods .( Not included are sales tax, grocery items, fresh meats, staffing, and delivery, serving supplies and catering fees.)

## Deposit & Billing

A deposit of 50 % of the total cost is due upon agreement of your order. **The balance is due, the next business day after your event.** Any changes or subsequent charges not included in this contract will be billed immediately after the event and is do upon receipt.

## Service Charge

18 % Service Charge is added to off set our administration cost, equipment wear and breakage.

## Event Planning

A personal event planner will help make your event unique, memorable and worry free. An event planner pays attention to all needed details for your Wedding, Bar or Bat Mitzvah, Birthday and Anniversary. They are experts in Jewish Simchas, able to fulfill special requests, create the perfect room ambiance and add those special touches.

## Staffing

Minimum of 4 hours will be billed for staff.

Fishman's to determine staff needs based on your menu and service needs.

Chef \$50.00/hour      Kosher Supervisor \$25.00/hour

Utility Person \$15.00/hour      Dishwasher \$12.00/hour

### **Event Location Fees & Rental**

Client is responsible for all Deposit, Charges & Fees at their chosen event location.

### **Off Premise Catering Delivery Charge**

\$50 minimum charge for all deliveries on catering orders under \$500.00.  
Orders over \$500.00 will be charged 10 % of the total.

### **No Out-Side Food or Beverages**

Fishman's cannot take responsibility for food items we have not prepared.  
We cannot serve any food items not prepared or ordered by us at any event.

### **Guest Count**

Final guest count must be turned into Fishman's **seven business days prior to the event.**  
No reduction in numbers will be accepted after this date.

### **Leftovers**

The customer is entitled to all meals, which are billed for, but not consumed. The customer is not entitled to the 6% amount of food that Fishman's Kosher prepares over the customer's guaranteed number for staffed catering events. Leftover meals will be made available to the customer and the conclusion of the event.

Upon acceptance of the leftover meals, The customer takes on all responsibilities for transportation and proper storage. The Customer is informed the all food must be cooled to 40°F or less within 2 hours. If hot food is to be reheated, it must be rapidly heated to an internal temperature of 180° F.

The customer agrees that acceptance of said meals at the conclusion of the event, that Fishman's Kosher is released from all claims, damages, causes of action or liabilities which may result of the consumption of said meals.

### **Cancellations**

Cancellation of event with less then Seven days notice, Fishman's shall retain 10 % of your deposit. Cancellation fourteen days prior to the event, Fishman's shall return your deposit.
